- Monthly reporting of schedules can be negotiated based upon fleet size

# Motor Truck Cargo (MTC)

- Up to USD 500,000 any one unit
- Up to USD 500,000 any one loss

# Dealers Open Lot (DOL)

- Up to USD 5,000,000 any one loss
- DOL policies provide auto physical damage for dealer's vehicles held for sale. The coverage includes damage resulting from fire, weather, explosion, theft, vandalism or collisions.

### Garage Keeper's Legal Liability (GKLL)

• Up to USD 5,000,000 any one loss

• GKLL provides coverage for businesses owners who look after privately owned vehicles such as garage businesses and car parks. It protects the customer's vehicle when it is in the care, custody and control of the garage or parking lot against theft, vandalism or collision.
